1385. Policing Matters:

It was agreed that the Clerk would write to them and emphasise the issues of drug taking and possible damage to property in that area.

1386. New Location for Litter Bin (currently located by the Parish Noticeboard):

The Chair had spoken to the Chair of the Village Hall Committee who agreed that they would be happy for the litter bin to be relocated to the car park of the Village Hall close to the stile where dog walkers access the footpath. They would cover the cost of approx. £80. It was then discussed as to whether we still needed a litter bin/dog waste bin in the heart of the village and the Chair agreed to look into the cost of this.

1387. Highway Matters:

The Chair has engaged with Sarah Barnwell from NNC on a number of highway matters.

- a) Speeding on Seaton Road: This was still causing considerable concern, particularly amongst residents of Seaton Road. The Chair requested NNC to impose a 20 mph limit in that area. There is a Committee Meeting later this month to review this at NNC.
- b) State of the roads: This was raised again with Sarah Barnwell with a request that the Council stop "patching up" and do proper resurfacing of the roads in bad areas.
- c) Deene Road junction markings: No progress has been made on this issue.
- d) Bollards on Jubilee Green to stop parking in that area: Cllr Walsh has a case number relating to a personal request to NNC about this. He would keep us updated.
- e) Illegal cropping of verge on Laxton Road adjacent to Spanhoe Lodge: The Chair has filed a new complaint with NNC regarding the flouting of a previous request to the landowner not to crop the verge.
